# BEING A BYLAW TO CONFIRM THE PROCEEDINGS OF COUNCIL

# **Legal Authority**

#### Scope of Powers

Section 8(1) of the *Municipal Act*, 2001, S.O. 2001, c.25, ("*Municipal Act*") as amended, provides that the powers of a municipality shall be interpreted broadly so as to confer broad authority on municipalities to enable them to govern their affairs as they consider appropriate, and to enhance their ability to respond to municipal issues.

#### Powers of a Natural Person

Section 9 of the *Municipal Act* provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act.

# Powers Exercised by Council

Section 5 (1) of the Municipal Act provides that the powers of a municipality shall be exercised by its Council

### Powers Exercised by By-law

Section 5(3) of the *Municipal Act* provides that a municipal power, including a municipality's capacity, rights, powers and privileges under section 9, shall be exercised by bylaw unless the municipality is specifically authorized to do otherwise.

#### Preamble

Council for the Corporation of the Municipality of Calvin ("Council") acknowledges that many of the decisions it makes during a meeting of Council, regular, special, or otherwise, are done by resolution. Section 5 (3) requires that Council exercise their powers by Bylaw.

Council further acknowledges that the passing of resolutions is more expedient than adopting Bylaws for each decision.

#### Decision

Council of the Corporation of the Municipality of Calvin decides it in the best interest of the Corporation to confirm its decisions by way of Confirmatory Bylaw.

#### Direction

**NOW THEREFORE** the Council of the Corporation of the Municipality of Calvin directs as follows:

- The Confirmatory Period of this By-Law shall be for the Special Council Meeting of November 22, 2022.
- 2. All By-Laws passed by the Council of the Corporation of the Municipality of Calvin during the period mentioned in Section 1 are hereby ratified and confirmed.
- 3. All resolutions passed by the Council of the Corporation of the Municipality of Calvin during the period mentioned in Section 1 are hereby ratified and confirmed.
- 4. All other proceedings, decisions, and directives of the Council of the Corporation of the Municipality of Calvin during the period mentioned in Section 1 are hereby ratified and confirmed.
- 5. This Bylaw takes effect on the day of its final passing.

# 4 Comments By Incoming Mayor Richard Gould

Comments as provided by Mayor Gould:

Good evening. It is wonderful to see you all here tonight and I would like to thank Jacob Grove, Penny Young Lovelace and Barbara Major for organizing this evening.

I would also like to thank the previous council for their contributions. Although we may not have shared the same philosophy, I know in my heart, that their efforts were based on a desire to serve the community.

We now have an entirely new council and we all have much to learn, but I know that these new council members are also here because of an honest desire to serve and to leave Calvin a better place. Moving forward we have many challenges to face, but make no mistake, we have an excellent council. Debbie Adams will not tolerate any nonsense and she will be quick to make sure council is not fooled by those pretending to have good intentions. Bill Moreton will be the calming voice and will keep us on balance. Dean Grant will be the voice of idealism and will push us forward. And Robert Latimer will be the realist making sure we avoid hasty of the township.

This entire council has been given a clear mandate. In the recent elections across Ontario, the average voter turnout was 36%, but in Calvin it was over 54%. This should tell everyone here that there are expectations. We have an obligation to answer to the citizens who have shown us their confidence and their support.

It would be easy to fall into the old habits of poor communication and keeping things status quo. But most of the newly elected councillors have stated that they would work toward inperson meetings, public involvement better communication. If we don't do this, we will not fix the division, anger and hatred that has become all too common in Calvin. Some have suggested that social media is the creator of hatred and division. I don't believe this to be true. I believe hatred is a human condition that comes from people feeling isolated, disenfranchised, and alienated. And this often comes from lack of communication. It's true that social media allows hatred to be spread more easily, but hatred can be spread putting letters into people's mailboxes, by making disparaging comments out in public, or even flipping the bird to people as they pass or drive by in vehicles. My beloved Granny, born and raised in Belfast, Ireland told me how destructive this tribalism and hatred for one or another group can be. All of this must stop. Inuendo, accusation and revenge must be a thing of the past. Social media is a place to tell people about a missing dog, a community event, or a road hazard. Mail is for greeting cards and sharing information. And a hand gesture is for waving hello to a neighbour as they pass. I have no doubt that one day I will see on social media a caricature of a fuddy duddy mayor with the label mayor Gouldfinger . . . and that is alright, as long as it is not done in hatred. In the new year I hope to set up office hours in the township office to meet members of the public and hear their concerns. There may be people who will not like the

decisions of council, but in advance we will always be willing to listen with an open ear. However, if someone comes to me with hatred in their heart looking for revenge or retribution, they will find that I am not sympathetic.

We have a great staff to work with. Our roads have always been top notch and our fire department is staffed by hard working and dedicated volunteers. And finally, our admin department and public works have been working very hard given the turmoil and disruption they have faced. We applaud all the efforts of staff.

We all must learn to work together, so that we can face new challenges of the future. The deteriorating hydro electric delivery systems, global warming and the changes being introduced by the federal and provincial governments, poor internet and cell phone coverage, a lack of commercial services, increased costs of downloaded government programs, and even Cassellholme are all items we will have to deal with. I would hope that before the end of this year, as we work on uniting the township, all members of council will work on a council term plan. Early in the new year we will come up with a long-term plan of what we hope to accomplish. In the coming weeks, I ask each councillor to create a list of some of the things they want to see happen during their term in office. We will then have an open meeting with the public to gain input. And then we will move forward.

Finally, I want to repeat something one of our constituents said to me. I was speaking with Ted Myers and he told me he supported the idea of bringing an end to the division in the township. He suggested that if we really want to be successful at ending hatred and vengeance, we have to make decisions just 18 inches away from our heads – we have to start making decisions also based on our hearts.

So, lets work heart and soul, with openness and dedication and make this a memorable fouryear term. Thank you for your involvement.

# Think You'll Win? Know The Odds of Winning Big

NORTH BAY, ON - The North Bay Parry Sound District Health Unit (Health Unit) and the Community Counselling Centre of Nipissing are relaunching Think You'll Win? a gambling harm reduction campaign that adds perspective to the odds of winning big. The campaign features four new scenarios that may seem unbelievable, but are statistically more likely to happen than winning big.

- Think You'll win big at roulette? You're more likely to have royal ancestry.
- Think you'll pick a perfect ½ bracket? You're more likely to have quintuplets.
- Think you'll win the next bingo round? It's more likely a player shares your birthday.
- Think you'll win at online slots? You're more likely to crack a code on the first try.

"The original campaign's lighthearted approach resonated with the community, so we expanded the campaign to highlight the odds of other forms of gambling, such as bingo and sports-betting," says Justine Mallah, Community Health Promoter at the Health Unit and Co-chair of the Gambling Harm Reduction Partnership. "Being informed about odds and how the game works before you bet are important steps to safer gambling."

Research shows that people with mistaken beliefs about the odds of winning are more likely to face gambling harms.

"Many people believe inaccurate information about gambling and odds," says Mallah. "Gambling is not a money-maker, and it is far less likely that you will win big, than you may think. For instance, think you'll win at online slots? You're more likely to crack a 4-digit code on the first try."

The rise of online gambling during COVID-19 and the relaxing of laws around sports betting sparked the campaign's expansion.

"Increased access to gambling is linked with increased risk of gambling harms to individuals and the community," Mallah adds. "Gambling for fun is not a problem, but when used as a tool for income, to pay off bills or to win back money, for example, it is a problem."

Problem gambling can affect anyone no matter their socioeconomic status. People with moderate or severe problem gambling and those close to them are more likely than the general population to experience other negative health and social impacts. The impact of problem gambling on community well-being is far reaching, with higher rates of depression, suicide, substance use disorders, homelessness, criminality and being victims or perpetrators of domestic and inter-partner violence, according to the data.





AMO's land use planning 2.0 training is designed to support Ontario's elected officials in the strategic decision making and management of the many facets of land use planning.



THAT the Town of Carleton Place recognizes the issues of violence in rural communities as serious to the health and wellness of local families; and

THAT the Town of Carleton Place recognizes the rural Renfrew County inquest as important to all rural communities; and

THAT based on the statistics of 4815 crisis calls and service provision to 527 women and children in our local community, the Council of the Town of Carleton Place declares IPV (intimate partner violence)/VAW (violence against women) an epidemic as per recommendation #1 of the Renfrew County jury recommendations; and

THAT this resolution be circulated to all municipalities in Ontario and the Association of Municipalities of Ontario.
