

Many new opportunities have come along for citizens who wanted to work from home or have had the opportunity to come and live in Calvin because they can work remotely. As a Council, Covid has opened up new opportunities for us to conduct the business of the community via on-line and live streamed to ensure greater transparency and accountability for all of us. As a new Council we have also had to work with a new Integrity Commissioner and the importance of this for every citizen should be clear. The oversight and compliance to the code of conduct should be and remain one of the most important aspects of Council administration and responsibility to accountability to their community.

The past few years have also brought many accomplishments and progress to Calvin Township, almost too many to list here in this newsletter. A few of the more notable goals and priorities for this Council included keeping taxes low and programs and services moving forward. Council also invested time into training, bought a new fire truck, provided funds for a new renovation, and upgraded the heating at the fire hall as well as added a new municipal garage roof and upgraded heating system, drilled new water wells, and installed both a new wheelchair access, renovated the women's and men's bathrooms and installed air conditioning at Town Hall for those requiring these, such as staff. The Town Hall is also dedicated as an Emergency Centre which is why the upgrades were made. With the assistance from a Provincial grant, Council purchased a new road grader for the Roads Department. Council also implemented a new electronic payment system to ensure vendors were quickly and appropriately compensated. This Council also adopted a new official Zoning By-Law which was years in the making and will place the community in a much better development position for the future.

As Mayor and Council, we also want to take this opportunity to thank our current and past staff at Town Hall for their patience and dedication toward the administration of this community. We have and continue to make staff a priority and we want to ensure they have a safe, strong, and healthy workplace here in Calvin. As we continue to work hard to close off this term of Council, we also want to thank those who have or will be placing their name on the election ballot for October 24, 2022. As a Council and community we should all have one goal when it comes to Calvin Township.....remember build tomorrow by working together today!

Burning Regulations 2022

Make sure you know the rules for outdoor fires and follow safe practices. Each year dozens of residents and cottagers across Ontario lose structures and property to fire caused by careless burning. Your Fire Department would like to remind you that **outdoor burning regulations are enforced between April 1 and October 31.** If you burn, follow these steps:

Choose a safe time

Any fire is most likely to get out of control on a hot, dry or windy day. Burn during the coolest dampest and calmest time of day. **Two hours before sunset, or**

Stay in control of your fire

Many injuries are caused by careless use of flammable materials and underestimating fire behavior. Never use gasoline to start your fire as it is highly explosive. A

later, and extinguish two hours after sunrise.

Don't even consider burning when it is windy. Be aware that in the spring after the snow melts and before the grass and buds have started to grow, it is extremely hazardous to burn.

Choose a safe site

If you are burning an area of grass or leaves, make sure the area is surrounded by a fireproof boundary. Roads, ditches, or ploughed ground provide good barriers against fire spread. Your fire should be at least 18 meters (50ft) away from any structure or forest debris that might catch fire.

Put that fire out

Remember, coals can smolder for hours and hot embers can be blown by the wind, easily setting fire to dry grass or twigs. Drown hot coals thoroughly, and then cover with sand or gravel. responsible person must be available to tend the fire at all times, even if it is contained in an incinerator. You must have adequate tools (shovel, rake) and water on hand to control the fire if it begins to spread. Use caution around hydro poles and be aware of overhead and underground cables. Be sure your fire does not cause irritation or inconvenience to your neighbors.

Keep your fire small

Small fires can be controlled by one person using hand tools and water. When burning piles of wood, brush or wood byproducts make sure it's less then 2m (6.5ft) high and 2m (6.5ft) in diameter. Keep your fires limited to one pile burning per acre. Burning an open field is not a good idea, but if it is necessary make sure you have the equipment and people available to do it safely.

DON'T BURN DURING THE DAY

It is your responsibility to be aware of the Rules, Regulations and By-laws pertaining to outdoor burning in this area. Your municipality follows the provisions of the Forest Fire Prevention Act. The O.P.P. and M.N.R. have the authority to lay charges if you are found negligent.

At any time, the M.N.R or Fire Department may ban or restrict outdoor burning in this area until further notice. Be aware that if a forest fire results because you have used fire improperly, you could be held responsible for the cost of putting out the fire and any property damage that may occur.

INFORMATION ABOUT INTERNET/TELEPHONE VOTING

The Municipality of Calvin will be utilizing telephone and internet voting for the 2022 Municipal election. There will be no paper ballots.

During the Voting Period which commences at 9:30 a.m. on Friday October 14th, 2022 and continues until 8:00 p.m. on Monday October 24th, eligible voters will be able to vote from anywhere they can access the internet or telephone.

All eligible voters will receive a Voter Information Letter (VIL) by mail. This sealed personalized envelope will contain a Personal Identification Number (PIN) and a telephone access number, a secure Internet address for voting and instructions on how to cast your vote. You will be required to use a PIN, and, along with your date of birth, you will be able to access your ballot. The personalized Voter Information Letter (VIL) will be mailed to you prior to the Voting Period. The VIL with the PIN is to be kept in a safe place until voting opens and should be treated the same level of confidentially as reserved for your bank card and PIN.

VOTING PERIOD

The Internet/Telephone Voting Period will commence on Friday, October 14th, 2022 at 9:30 a.m. until 8:00 p.m. on Monday, October 24th, 2022.

In order for eligible electors of the Municipality of Calvin to receive their personalized Voter Information Letter (VIL) they must be on the Municipality of Calvin Voters' List. Visit www.voterlookup.ca to confirm if you are on the Voters' List.

ADDITIONS/REVISIONS TO VOTERS'LIST

Commencing September 1st a person may make application requesting that their name be added to or removed from the Voters' List or that information on the Voters' List relating to them be amended by completing and filing the *Application to Amend Voters' Lists* form which is available at the Municipal Office and the website www.calvintownship.ca

The application shall be in writing and shall be filed in person or by mail by the applicant or his/her agent. Proof of identity and residence as prescribed in *O. Reg 304/13* will be required of the applicant. If the applicant does not appear in person, a certified copy showing proof of identification and proof of residency/occupancy is required.

** Please note that the Municipality of Calvin office is closed on Thursdays to the public and the telephone is not answered. Please do not leave messages.

QUALIFICATIONS OF ELECTORS

A person is entitled to vote in a municipal election if he or she on voting day,

- ➤ Is a Resident in the Municipality of Calvin, or is the owner or tenant of land in the Municipality or the spouse of such owner or tenant, and
- Is a Canadian citizen, and
- Is at least 18 years old, and
- > Is not prohibited from voting by law.

CHALLENGES IN EMPLOYEE RECRUITMENT – 2022

It is no secret that Calvin Township has had its number of challenges finding capable, qualified, and dedicated staff to administer and manage the offices, as well as provide Mayor and Council with the bureaucratic support, leadership and guidance that is required to operate this community in an efficient and effective manner. BUT Calvin Township is not alone, and this is NOT a unique situation or challenge that only applies to this community but many across this province. In fact, it is becoming such a significant issue across so many small communities that anyone with any significant and base level skills in municipal administration could shop around for the best compensation, relocation, hyflex and operating package before committing to one specific community. Many small communities have to now invest, attract, and search out municipal professionals in a way that they would have never before. Communities with under 5,000 people are now hiring professional talent search companies to attract municipal administrators from other parts of the Province with lucrative contracts that involve relocation and other expenses. The days of overwhelming resume responses to search advertisements in publications is no longer the case. Small rural communities in Ontario are having many challenges attracting and retaining municipal staff and the choices to fill these positions are limited. Another option that small communities have turned to, is the hiring of less qualified individuals and significant time and money investment in "onthe-job training" activities that require professional trainers to come into the workplace on a contract basis to train while these employees work. Not cheap.


Regardless, the recruitment of trained and qualified individuals for Calvin Township was and will continue to be a significant challenge moving forward into the next Council term.
