# 2022 Municipal and School Board Elections

Municipality of Calvin eligible voters are reminded that telephone and internet voting for the 2022 Municipal and School Board elections is available 24 hours a day during the Voting Period starting on <u>Friday October 14, 2022 at 9:30 a.m.</u> through to <u>Monday October 24, 2022 at 8:00 p.m.</u> Election Day is on October 24, 2022.

# VOTER HELP CENTRE

A Voter Help Centre will be set-up at the Municipality of Calvin Council Chambers on the following dates and times for internet voting:

- > Friday October 14, 2022 from 9:30 a.m. to 4 p.m.;
- > Monday October 17, 2022 from 10 a.m. to 4 p.m.;
- > Wednesday October 19, 2022 from 10 a.m. to 4 p.m.;
- > Friday October 21, 2022 from 10 a.m. to 4 p.m.;
- > Monday October 24, 2022 from 10 a.m. to 8 p.m.

If you plan to visit the Voter Help Centre to cast your vote, bring your voter information letter containing your unique PIN and identification that has your name and address on it. Staff will check if you are eligible to vote before directing you to the voting area where you will go behind a voting screen and use a computer or an iPad to cast your vote. There will be no paper ballots.

Your Voter Information Letter should arrive in the mail by <u>October 12<sup>th</sup></u>. If you haven't received it by October 14th, contact the Help Desk at 705-744-2700 for assistance.

- Keep the Voter Information letter in a safe place until voting opens on **Monday, October 14, 2022 at 9:30 am**.
- You will be able to vote anytime between 9:30 am on October 14 and Monday, October 24 at 8 p.m. Don't wait till the last day to vote as it may be busy.
- The Voter Information letter contains your **PIN** that will grant you access to the voting system. The letter also contains Help Desk hours and phone number.

#### ADDITIONS/REVISIONS TO VOTERS' LIST

A person may make application requesting that their name be added to or removed from the Voters' List or that information on the Voters' List relating to them be amended by completing and filing the *Application to Amend Voters' Lists* form which is available at the Municipal Office and the website www.calvintownship.ca

To be added, deleted or to make any corrections to the information on the Voters' List, visit the Municipal Office at 1355 Peddlers Drive, Municipality of Calvin or telephone 705-744-2700 for information. <u>Bring acceptable proof of identity and residency with you.</u>

\*\*Please note that the office is not open to the public on Thursdays and the telephone is not answered.

#### **INTERNET/TELEPHONE VOTING**

There are 2 ways to vote:

- 1. **<u>By phone</u>** (takes about 3-5 minutes)
  - Call the number provided in your Voter Information letter
  - Enter your date of birth in the order that the voice tells you to
  - After entering your birth date, press the <u># sign</u>
  - Enter your **PIN** followed by the <u># sign</u>
  - If you receive an error after several attempts to login, this may be because your date of birth information is incorrect in our Voting System. Please contact the Voter Help Centre/Municipal office (number is on your letter) and speak to elections staff to verify your details in our system.
  - If you are interrupted before you finish voting, you can call back, re-enter your birth date and PIN and the system will take you to where you left off.
- 2. <u>Vote online</u> (takes about 2 minutes)
  - Visit the voting website provided in your Voter Information letter by entering the address (also in your Voter Letter) into the address bar at the top of your internet browser (Chrome, Firefox, Safari, etc.)
  - Enter your Date of Birth
  - Enter your **PIN**
  - Enter the Captcha challenge (distorted letters and numbers) as shown on the screen
  - If you receive an error after several attempts to login, this may be because your date of birth is incorrect in our Voting System. Contact the Voter Help Centre/Municipal Office (number is in your letter) and speak to elections staff to verify your details in the system.
  - Follow the prompts through all the screens and complete your ballot by pressing Cast Ballot.
    Once you have cast your ballot, you will not be able to go back if you change your mind it is the same as if you put your paper ballot into the ballot box.
  - If you get interrupted before you finish voting, you can log back in again and the system will pick up where you left off.

<u>Reminder:</u> Section 89 of the Municipal Elections Act states, *A person is guilty of an offence if he or she,* votes without being entitled to do so andvotes more times than this Act allows. You may only vote once in the municipal election regardless of how many properties you own or rent within the Municipality.

#### ELIGIBILITY TO VOTE

To vote in the Municipality of Calvin municipal election, you must be:

- a Canadian citizen; and
- at least 18 years old; and
- a resident in the Municipality; or
- a non-resident of the Municipality, but you or your spouse own or rent property in the Municipality; and
- not prohibited from voting under any law.

# 2022 Municipal Election Voter Identification



**Identification will be required** when you attend at the Voter Help Centre or the Municipal Office for additions/amendments to the Voters' List or when issuing an oath. Remember to bring one (1) or more piece(s) of identification showing your name and qualifying Municipality of Calvin address.

Your Voter Notification Card cannot be used as a piece of ID. If you are not on the voters' list and do not have acceptable ID, you will be asked to return with identification showing a qualifying municipal address.

#### ACCEPTABLE DOCUMENTS FOR IDENTIFICATION

# In accordance with the Municipal Elections Act, 1996 and Regulation 304/13 proof of identity is required. When you vote, you MUST prove your identity and residential address.

List of Acceptable documents for Identification:

- 1. An Ontario Driver's licence
- 2. An Ontario Health Card (photo card)
- 3. An Ontario Photo Card
- 4. An Ontario motor vehicle permit (vehicle portion)
- 5. A cancelled personalized cheque
- 6. A mortgage statement, lease or rental agreement relating to property in Ontario
- 7. An insurance policy or insurance statement
- 8. A loan agreement or other financial agreement with a financial institution
- 9. A document issued or certified by a court in Ontario
- 10. Any other document from the government of Canada, Ontario or a municipality in Ontario or from an agency of such a government
- 11. Any document from a Band Council in Ontario established under the Indian Act (Canada)
- 12. An income tax assessment notice
- 13. A Child Tax Benefit Statement
- 14. A Statement of Employment Insurance Benefits Paid T4E
- 15. A Statement of Old Age Security T4A (OAS)
- 16. A Statement of Canada Pension Plan Benefits T4A (P)
- 17. A Canada Pension Plan Statement of Contributions
- 18. A Statement of Direct Deposit for Ontario Works
- 19. A Statement of Direct Deposit for Ontario Disability Support Program
- 20. A Workplace Safety and Insurance Board Statement of Benefits T5007
- 21. A property tax assessment
- 22. A credit card statement, bank account statement or RRSP, RRIF, RHOSP or T5 statement
- 23. A CNIB Card or a card from another registered charitable organization that provides services to persons with disabilities
- 24. A hospital card or record
- 25. A document showing campus residence, issued by the office or officials responsible for student residence at a post-secondary institution
- 26. A document showing residence at a long-term care home under the *Long-Term Care Homes Act, 2007,* issued by the Administrator for the home
- 27. A utility bill for hydro, water, gas, telephone or cable TV or a bill from a public utilities commission
- 28. A cheque stub, T4 statement or pay receipt issued by an employer
- 29. A transcript or report card from a post-secondary school
