The Federation of Northern Ontario Municipalities (FONOM) would like to commend the Province of Ontario for taking a giant step forward in improving waste diversion and protecting the environment.

Today, Ontario's Environment Minister Jeff Yurek formally announced the final regulation to transition the Blue Box program from municipalities to producers. When fully implemented, this regulation will go a long way in addressing litter in our communities, reducing single-use plastics making their way into watercourses and expanding the Blue Box program into new communities in Northern Ontario.

"This regulation has been looked at by three consecutive governments. I would like to recognize Premier Ford and Minister Yurek for having the courage to introduce this regulation, which will not only benefit our environment but will remove the cost of the Blue Box program from property taxes," stated FONOM President Danny Whalen

FONOM has been actively working for nearly a decade with AMO, M3RC, OWMA, and municipal staff from across the province on the framework for this regulation. Additionally, FONOM's membership has been instrumental in ensuring that all Northern and Rural Ontario (excluding those in the far north) is included in the transition.

"I would like to applaud the team that AMO assembled from across the province," stated President Whalen. "Staff from the City of Toronto and other regions within southern Ontario were instrumental in ensuring Northern Ontario is included in the regulation."

The FONOM Board would like to thank AMO's Board and Staff for the advocacy on this file on behalf of our members. Monika Turner, Dave Gordon, and Amber Crawford have worked tirelessly on this issue with Stewards and the Government, along with FONOM's own Councillor Mac Bain.

Some of the highlights of the Regulation are:

- Staggered transition from municipalities from 2023 to 2025
- Expanding collection to all communities outside the Far North by 2026;
- Standardizes what can be recycled across Ontario;
- Includes municipalities under 5,000 population
- Accepting common single-use and packaging-like products such as paper and plastic cups, foils, trays, bags, and boxes sold for home use;
- Collecting single-use items that are distributed or sold to consume food and beverage products, like stir sticks, straws, cutlery, and plates;



- Expanding services to more facilities such as apartment buildings, municipally run or non-profit long-term care homes and retirement homes, and schools;
- Expanding collection to more parks, playgrounds, and transit stations, more than tripling the number of public space recycling bins funded under the current program so there are more opportunities to recycle at home and on the go.
- Ensures existing deposit return programs such as The Beer Store will continue.

FONOM is an association of some 110 districts/municipalities/cities/towns in northeastern Ontario mandated to work for the betterment of municipal government in Northern Ontario and to strive for improved legislation respecting local government in the north. It is a membership-based association that draws its members from northeastern Ontario and is governed by an 11-member board.

support lower premiums or alternatives to the provision of
insurance services by other entities such as nonprofit insurance

6. Compel the insurance industry to supply all necessary financial evidence including premiums, claims and deductible limit changes which support its own and municipal arguments

as to the fiscal impact of joint and several liability. 7. Establish a provincial and municipal working group to consider the above and put forward recommendations to the Attorney General;

NOSM to Become First Stand-alone Medical University in Canada

Social accountability mandate drives innovation in education and health care.

Today, the Government of Ontario passed legislation to make the Northern Ontario School of Medicine (NOSM) a university. With this status, NOSM becomes the first stand-alone medical university in Canada.

"This is a historic occasion for our medical school and all of Northern Ontario," says Dr. Sarita Verma, Dean, President and CEO of NOSM. "We are grateful to Minister Romano and the Ford Government for this incredible transformation, as the first medical school in Canada founded with a social accountability mandate we are now the first medical university of its kind in the country."

NOSM was established as a government strategy to address the health needs of the region, improve access to quality care, and contribute to the economic development of Northern Ontario. It was born of a grassroots movement, from communities across Northern Ontario advocating for a solution to regional health inequalities. Becoming a university translates that vision into a reality in the future.

Since opening its doors in 2005, NOSM has produced 714 MDs, 48 self-identify as Indigenous, 151 self-identify as Francophone with an additional 66 MDs set to graduate this spring. In addition, 579 residents have completed NOSM programs. More than half of these health practitioners have stayed in Northern Ontario, with the majority establishing their practice in Sudbury and Thunder Bay.

"The Government is proud to support this legislation to grow world-class postsecondary education in Northern Ontario. Thanks to this legislation, Hearst will become Ontario's second independent Francophone university, governed by and for Francophones. NOSM will become Canada's first standalone independent medical school and be empowered to expand its current services and programs and address the health needs of the region. The legislation represents a major opportunity for Northern Ontario to build and expand two new independent universities. In the coming months the Ministry will be working with the two institutions and with northern communities and stakeholders about the details of how NOSM and Hearst will operate in the future," says Ross Romano, Minister of Colleges and Universities.

NOSM's latest strategic plan, The NOSM Challenge 2025, will move forward with addressing the urgent crisis in physician workforce and health education and research reform.

"We will build upon the strength of our flagship campuses in Sudbury and Thunder Bay, with an expanded medical school, new residency programs innovated health professional education, population based research within a pan-northern regional model. This is exciting for all of Northern Ontario," says Dr. Verma. "NOSM University will have an immense impact on the health and wealth of Northern Ontarians."



NOSM will begin broad consultations about the next steps over the summer months. More information about this will be communicated publicly in the coming weeks.

NOSM is an award-winning socially accountable medical school renowned for its innovative model of distributed, community-engaged education and research. With a focus on diversity, inclusion, and advocacy for health equity, NOSM relies on the commitment and expertise of the peoples and communities of Northern Ontario to educate health-care professionals to practise in Indigenous, Francophone, rural, remote and underserved communities.

- NOSM was established as a separate legal entity an independent not-for-profit corporation with its own Board of Directors. Its affiliation with Laurentian University and Lakehead University was for the purpose of conferring degrees.
- Other than the degree granting authority, all other operational and academic aspects of the medical school are established under NOSM's authority.
- The NOSM MD program is independently accredited by the Committee on Accreditation for Canadian Medical Schools (CACMS) and the Liaison Committee on Medical Education (LCME). NOSM's accreditation will not change by becoming a university.

Speeding on provincial, county and municipal roadways continues to put the lives of Ontarians at risk. While we have access to several tools to help mitigate speeding traffic, the one tool that is currently not fully available to us is Automatic Speed Enforcement (ASE) (aka Photo Radar). Over the past decade, in South West Oxford the vast majority of charges laid are for drivers travelling well in excess of the posted speed limit. The cost of providing police time for something that could be done through the use of technology is disturbing to our council. The Council feels that it would be far more effective to have police concentrate on other problems such as Break and Enters, illegal drugs and domestic problems.

AND WHEREAS Ontario is the only province in Canada that empowers a separate adjudicative tribunal to review and overrule local decisions applying provincially approved plans;

NOW THEREFORE BE IT RESOLVED THAT in the short term, the Minister of Municipal Affairs and Housing immediately restore the amendments to the Planning Act that mandated the evaluation of appeals on a consistency and conformity with Provincial policies and plans basis;

AND FURTHER THAT in the long term the Government of Ontario eliminate the LPAT entirely, as an antiquated body that slows delivery and adds costs to housing supply via expensive and drawn out tribunal hearings;

AND FURTHER THAT this resolution be forwarded to the Premier, the Minister of Municipal Affairs and Housing, Halton's Members of Provincial Parliament, Leaders of the New Democratic, Liberal and Green parties, the Association of Municipalities of Ontario, the Small Urban Mayors' Caucus of Ontario, Mayors and Regional Chairs of Ontario and Halton's local municipalities.

Ontario's new blue box regulation and resources for the road ahead

As announced Thursday June 3, Ontario's new blue box regulation (O. Reg. 391/21) under the Resource Recovery and Circular Economy Act, 2016 has been finalized and is now published on e-Laws at: <u>https://www.ontario.ca/laws/regulation/r21391</u>

The regulation, which will transition Ontario's blue box program to an Individual Producer Responsibility framework, brings into focus the path ahead for current municipal and First Nation blue box program operators. Some initial highlights are outlined below.





Information about the regulation can also be found on <u>RPRA.ca</u>.



Specific transition dates now available

For the 253 municipalities, local service boards and First Nation communities that provided blue box services in 2019 under the Waste Diversion Transition Act, 2016, Producers will begin to assume operational and financial responsibility for delivering these services starting **July 1, 2023**, and finishing the transition by December 31, 2025. Specific transition dates for municipalities are outlined in the <u>Transition Schedule</u>.

Registration deadline end of September

Municipalities or local service boards are required to report preliminary information about their current blue box collection systems to RPRA on or before **September 30, 2021**. First Nation communities are required to report on or before November 30, 2021. Deadlines for additional registration requirements are also set, depending on the year your community will transition:

- September 30, 2021 for communities transitioning in 2023
- August 31, 2022 for communities transitioning in 2024
- August 31, 2023 for communities transitioning in 2025

Eligible sources

As written in the final regulation, eligible sources, to which a producers will have a duty to collect, include permanent and seasonal dwellings; multi-unit residential buildings; elementary and secondary schools, longterm care homes & retirement homes (excluding for-profit operations), as well as specified public spaces. With respect to public spaces, producers are to provide and collect from a minimum number of bins per capita and provide flexibility to place bins in parks, playgrounds, sidewalks and public transit stations and stops, according to a frequency that would collect materials from the receptacles before they would ordinarily be full.





Service standards during transition period

The service standards during the transition period were amended to allow Producers the option to either:

provide collection services consistent with what a local community delivered as of August 15, 2019, or
 provide collection according to the 2026 service standards, including all designated materials.

In both options, producers must maintain the collection frequency previously provided by the municipality until 2026. **As of January 1, 2026**, producers would also be required to provide services to eligible communities that were not listed in the <u>Transition Schedule</u>.

Current service providers will not have a right of first refusal

As was in the draft, the regulation does not require Producers and/or PROs to offer municipalities the right of first refusal to provide those collection services as was the case in British Columbia when that province transitioned to full producer responsibility.

Resources, Training and Support

As many already know, the CIF has been working behind the scenes for months to anticipate what our stakeholders will need to navigate this transition. In partnership with AMO's Municipal Resource Recovery and Research Collaborative (M3RC), the CIF launched a <u>Transition Working Group</u> to develop a range of tools, templates and training packages that will help prepare all Ontario municipalities and First Nations communities to transition their blue box programs to the Individual Producer Responsibility (IPR) framework.

The Transition Working Group subcommittees are currently developing:

- guidance for how to determine and register all eligible sources (e.g., single and multi-family sites)
- contract management training to address service delivery concerns in the lead up to transition
- decision trees and asset valuation assistance to help plan for a smooth transition

CIF will also be hosting Transition Planning Sessions in the coming months to help with the identification of critical collection, administrative changes and subsequent decisions resulting from transition. The course will provide guidance on how to address them and help municipalities and First Nations groups to begin to build out transition plans that meet their individual needs.

On February 16, 2021 Bill C-21, a bill that makes changes to the Criminal Code and the Firearms Act, and targets law abiding firearms owners, was introduced and is being debated in the House of Commons. Conservatives constituently call for cracking down on illegal gun smuggling, trading, gang and crime gun use, but Bill C-21 misses the mark if the aim really is to improve and protect the personal and public safety of Canadians. Bill C-21 focuses on the wrong people and groups, while also creating uncertainty and adding undo pressure on other levels of government.

Bill C-21 includes provision to allow municipalities to create handgun bylaws, which would place conditions on federal firearms licenses relating to handgun use, storage, or transportation within municipalities that have passed such bylaws.

Residents in cities and other places, with ever increasing gang shootings and violence rightfully expect their government ought to be taking action to keep them safe, but a regulation that gives municipalities the ability to pass bylaws does not do that. The municipal provision in Bill C-21 would be a bylaw on licenses, so this measure literally, specifically, and only targets Canadians who have licenses. This does nothing to stop dangerous criminals who certainly would never comply with a municipal bylaw when they do not obtain their guns legally, do not get licenses and who frankly do not care about criminal laws. What this purposed municipal bylaw section would do is lead to yet another layer of confusing, overlapping regulations and a patchwork of rules for already law-abiding Canadians within and between communities, while violations could result in two years imprisonment or permanent license revocations.

I have been hearing from municipalities concerned with being tasked by the Federal government to create these types of bylaws. They are sharing fears about economic and housing impacts by the perception that one community has higher safety standards than others, or that law-abiding firearms citizens will literally be unaware they are in violation just by crossing a municipal boundary that has different bylaws.



Some municipalities are saying that they do not have the expertise to create these bylaws and certainly would not have the resources to enforce such regulations. They are also concerned these bylaws potentially violate their own provinces' jurisdiction. Some provinces in opposition to the federal legislation have already passed or are proposing laws that would prohibit this type of power to shift to individual municipalities. Saskatchewan has already passed such a provincial law, and Alberta's bill received royal assent on April 29, 2021.

Due to these concerns, some municipalities have already opposed Bill C-21 and have taken the steps to pass resolutions in opposition to this potential new power that they neither requested, nor have the resources to impose and enforce.

I have attached a copy of the resolution passed by the council in Kingsville, Ontario. I encourage you to seek feedback from your rate payers, and to discuss this issue in council. You may decide to pass a similar resolution on behalf of your community. Please feel free to advise my office if you do so, and to reach out if you require any additional information on Bill C-21.

AMO Policy Update – Province Announces Employment Services Changes and Phase 2 of Natural Gas Expansion Program in Rural, Northern, and Indigenous Communities

Employment Services Changes

The provincial government has <u>announced</u> that it is proceeding with a process to select service managers to oversee the planning, design, and delivery of employment services in defined catchment areas. This builds on the existing prototypes already established in: Peel, Hamilton-Niagara, and Muskoka-Kawarthas. The province-wide implementation will be phased over the next few years starting with lower complexity areas and is expected to be completed in 2023. Higher complexity areas such as Northern Ontario and Toronto will be in the final phase.

The Ministry of Labour, Training and Skills Development has communicated about the changes to municipal governments and District Social Service Administration Boards (DSSABs) that administer Ontario Works. They are eligible to apply to become an employment services manager and would compete with other potential vendors including non-profit organizations, post-secondary institutions, and private companies. Those municipalities and DSSABs that are not interested in applying or unsuccessful with their application, will have their current employment services function for Ontario Works clients transferred to the provincial Employment Services network under the new service manager. This happened in the first three prototype areas.

The first step in the completive bidding process is a Request for Qualifications (RFQ). The RFQ document will be available on the <u>Ontario Tenders Portal</u> under reference Tender #14920.

Expanding Access to Natural Gas

Yesterday, the Province <u>announced</u> that Phase 2 of the Natural Gas Expansion Program will allocate more than \$234 million to support 28 new natural gas expansion <u>projects</u> in 43 rural, northern, and Indigenous communities. Construction for projects under Phase 2 will begin as soon as this year, with all 28 expansion projects expected to be underway by the end of 2025.

MEMORANDUM TO: Municipal Chief Administrative Officers and Clerks

SUBJECT: Entering Step One of the Roadmap to Reopen

I am writing to you today to advise that at 12:01 a.m. on June 11, 2021, Ontario has moved into Step One of the Roadmap to Reopen (the "Roadmap"), the Government of Ontario's three-step plan to safely and cautiously reopen the province and gradually lift public health measures.

Step One of the Roadmap

In order to reopen safely, Step One will initially focus on resuming outdoor activities and permitting retail with restrictions. Public health and workplace safety measures, including maintaining physical distance, capacity limits and wearing face coverings in indoor spaces and whenever physical distancing is a challenge continue to apply in Step One.

See below for a high-level overview of Step One of the Roadmap, which includes, but is not limited to, the following measures. Please refer to <u>O Reg 82/20</u> for precise requirements:

- outdoor dining up to 4 people per table;
- outdoor fitness classes, personal training and sports training up to 10 patrons. No games or practices permitted;
- essential retail at 25% capacity and discount and big box stores can sell all goods;
- non-essential retail at 15% capacity and can sell all goods;
- retail stores in malls closed unless the stores have a street facing entrance;
- indoor religious services, rites and ceremonies including weddings and funerals at 15% capacity of the room;
- outdoors religious services, rites and ceremonies including weddings and funerals are permitted with capacity limited to permit physical distancing of 2 metres;
- horse racing, motor speedways without spectators;
- outdoor pools and wading pools with capacity limited to permit physical distancing of 2 metres;

- outdoor zoos, landmarks, historic sites, and botanical gardens with capacity limited to 15% for ticketed areas;
- day camps;
- overnight camping at campgrounds and campsites, including Ontario Parks.

However, I understand that the Medical Officer of Health for the Porcupine Health Unit is implementing a tailored approach to address the unique circumstances occurring in this geography, where COVID-19 cases remain high, at this time. There is specific guidance for those located in the Porcupine Health Unit's jurisdiction, where a more gradual approach to reopening shall occur. For those municipalities in this area, please contact the <u>Health Unit</u> for more information.

Orders under the *Emergency Management and Civil Protection Act* (EMCPA) and the *Reopening Ontario* (A Flexible Response to COVID-19) Act, 2020

Except for the closure of public lands for recreational camping which expired on June 11, 2021, as the Province moves into Step One, all other emergency orders currently under the EMCPA will remain in effect until June 16, 2021. Please note, the Lieutenant Governor in Council may further extend emergency orders under the EMCPA for up to 14 days at a time.

In addition, orders made under the ROA will remain in force until June 19, 2021, with the possibility of further extension if approved by the Lieutenant Governor in Council.

Enforcement of Orders

For offences under the ROA and EMCPA, police and other provincial offences officers, including First Nation Constables, special constables, and municipal by-law officers, have discretion to either issue tickets to individuals for set fine amounts or issue a summons under Part I of the Provincial Offences Act (POA) or to proceed under Part III of the POA by laying an information.

Police officers and other provincial offences officers have the authority to disperse gatherings or organized public events that are not complying with gathering/event limits and can temporarily close premises where prohibited gatherings or organized public events are occurring and require individuals to vacate.

The ministry continues to work with enforcement ministries and municipalities to collaborate and information share, including through the dedicated 1-800 Enforcement Support Line and email resource at <u>EssentialWorkplacesSupport.SolGen@ontario.ca</u>.

The province will remain in Step One for at least 21 days to evaluate any impacts on key public health and health system indicators. If at the end of the 21 days the province has vaccinated 70 per cent of adults with one dose and 20 per cent of adults with two doses and there are continued improvements in other key public health and health system indicators, the province will move to Step Two of the Roadmap.

Thank you for your dedication and ongoing cooperative efforts to help keep our communities safe and healthy. We have achieved a great deal together against COVID-19 and your work has played a key role in ensuring we can move safely into Step One.

WATERSHED CONDITIONS STATEMENT – Level 1 Low Water indicates that the received rainfall and/or streamflow in gauged watercourses are below normal and have met the Ministry of Natural Resources and Forestry (MNRF) criteria for low water. Level 1 is meant to be the first indication of a potential water supply issue.

Current Conditions:

Received rainfall at the North Bay Airport climate station for March, April, and May was a total of 113mm this year, which is 48.6% of the long-term average (1981-2010) of 232.5mm. Additionally, the received rainfall in the month of May was 19.4mm, which is only 20.1% of the long-term average (1981-2010) of 96.3mm. This meets the precipitation criteria to declare a Level 1 Low Water condition (precipitation < 80% of average). Despite recent rainfall in June, based on the weather forecast the 3-month precipitation average will still meet the criteria for low-water for the foreseeable future.

The 31-day average streamflows at the Chippewa Creek, La Vase River, and Wasi River gauges were 0.020m³/s, 0.071m³/s, and 1.002m³/s respectively. Chippewa Creek is currently 69.6% of its lowest average summer month flow of 0.287m³/s. The La Vase River is currently 24.7% of its lowest average summer month flow of 0.288m³/s. The Wasi River is currently 88.1% of its lowest average summer month flow of 1.137m³/s. All three gauged watercourses meet the spring streamflow criteria to declare a Level 1 Low Water condition (streamflow < 100% lowest average summer month flow).

Additionally, the 31-day average streamflow for Chippewa Creek, the La Vase River, and the Wasi River are all below their historical averages for this time of the year. The 31-day average streamflows for these watercourses are 34%, 9%, and 32% of their long-term averages for this time of year, respectively.

<u>Risk:</u>

Level 1 Low Water status is the first indication of a potential water supply problem, based on the precipitation and streamflow criteria established by the Ministry of Natural Resources and Forestry (MNRF).

Due to the lack of rainfall and low water levels across the watershed in some areas, all residents are encouraged to voluntarily reduce their water consumption, targeting an overall water usage reduction of 10%.

The vulnerability of municipal water supply systems within the North Bay-Mattawa Conservation Authority (NBMCA) area of jurisdiction was assessed through a water budget stress assessment as part of the Drinking Water Source Protection program. All municipal water intakes within NBMCA jurisdiction were determined to have a low level of risk, so we do not anticipate municipal water supply issues at this time. Private water systems were not assessed.

Low water levels in some areas means that submerged hazards may be closer to the surface than in the past. Boaters are encouraged to exercise additional caution in areas with low water.

Staff at NBMCA will continue to monitor weather and watershed conditions and provide updates if conditions change.

The general public is advised of these messages through the <u>www.nbmca.ca</u> website with the low water status icon and a link to information about current conditions. NBMCA also circulates these messages to local media and social media, posting on Twitter (@theNBMCA), Instagram (nbmcainfo), and Facebook (theNBMCA).

This message will remain in effect until further notice.

Terminology: Notification Levels

LEVEL 1 LOW WATER is the first indication of a potential water supply problem. A Water Response Team (WRT) may be convened. Voluntary water use reductions are encouraged, targeting an overall 10% reduction.

Level 1 is based on the following criteria:

- 18-month precipitation < 80% of average, or
- 3-month precipitation < 80% of average, or
- Monthly flow < 80% lowest average summer month flow, or

In Spring (i.e. April, May, June) only:

Monthly flow < 100% lowest average summer month flow.

LEVEL 2 LOW WATER indicates a potentiall serious problem. The WRT may contact individual water users and Permit To Take Water (PTTW) holders to encourage further water use reductions, targeting an overall 20% reduction.

Level 2 is based on the following criteria:

- 18-month precipitation < 60% of average, or
- 3-month precipitation < 60% of average, or
- 1-month precipitation < 60% of average, or
- 3 weeks with < 7.6mm rainfall, or
- Monthly flow < 50% lowest average summer month flow, or
- In Spring (i.e. April, May, June) only:
- Monthly flow < 70% lowest average summer month flow.

LEVEL 3 LOW WATER indicates the failure of the water supply to meet the demand, resulting in progressively more severe and widespread socioeconomic effects. The Ontario Water Director's Committee (OWDC) may support the WRT with further water use restrictions.

Level 3 is based on the following criteria:

- 18-month precipitation < 40% of average, or
- 3-month precipitation < 40% of average, or
- 1-month precipitation < 40% of average, or
- Monthly flow < 30% lowest average summer month flow, or

In Spring (i.e. April, May, June) only:

• Monthly flow < 50% lowest average summer month flow.
